Public Safety – thank you to CVFD and CPD for their help with our light up night.

President's Report – our light up night, "Carols and Lights" was fantastic. Thank you to our Mayor for arranging everything for this night. Thanks to Steve, our borough manager and our Administration and Department of Public Works for all their hard work to make this a successful event.

MANAGER'S REPORT – the "Rails and Trails" program we've been discussing, we received a grant for a study through Active Allegheny. Representatives from Carnegie Borough, Scott and Collier Townships walked the tracks from the borough building to Collier to get an idea of what the track would look like. That was the first step in our process.

We attended a public art focus group, an air quality control workshop, a DCNR grant workshop, and a Walkworks multi-modal transportation webinar. We submitted a streetscape enhancements grant to PennDOT which is for painting of the light poles that are currently turquoise. The administration completed a parking guide which includes all of the parking lots and parking spaces that would be available for residents and commuters. We added a web link on our site to pay Meter Feeder parking tickets. We received our 88 tables from the Char West COG CBDG Grant and we also submitted a CBDG Grant for the upcoming year.

For December, we moved from a Bronze to a Gold status for our Sustainable Pennsylvania certification and we submitted a USDA Farmer's Market Grant. We will be submitting a small sewer grant and we're continuing to work on getting our merchant accounts for parking for 2020.

CARNEGIE VOLUNTEER FIRE DEPT & EMS REPORT - for the month of November 2019 there were 15 fire calls and 104 ambulance calls.

MAYOR'S REPORT - Police Dept. activity for November 2019; Criminal Arrests and Citations – 22; Traffic Citations – 60; Traffic Stops – 91; Parking Tickets –186; Complaints and Self-Initiated Activity –837.

December Activities – "Tis the Season to Shop Locally" – everything you want for the holidays can be bought locally. We are gifting free parking from December 9th to the 20th. This coming Friday – December 13th from 5 p.m. to 9 p.m. is the Carnegie Crawl. This month's theme is the Santa Crawl.

Firebox Art Studios is celebrating their second anniversary during the Crawl from 6:30 - 8:30 p.m. and on Saturday the 14^{th} from 7-9 p.m. This will include free live music, food and drinks.

Saturday, December 14th from 8:30 a.m. to noon is Breakfast with Santa at the Carlynton High School. Tickets are \$8 for adults and \$5 for children. Proceeds will be used to sustain the "Food for Kids" backpack program, which provides weekly backpacks filled with food for needy families living in the district. Also on the 14th from 10 a.m. to 2 p.m. is the annual Cookie Walk at Sts. Peter and Paul Ukrainian Orthodox Church located at 200 Mansfield Boulevard. December 19th & 20th from 6 p.m. to 9 p.m., Santa visits Carnegie escorted by the Carnegie Volunteer Fire Department. Friday, December 20th is "Ugly Holiday Sweater Day" in downtown Carnegie. Wednesday, December 25th, there will be free Christmas Day dinners sponsored by the Church of Atonement and Sts. Peter and Paul Ukrainian Orthodox Church.

As we look back on this year we would be remiss if we did not reflect on the 125th Anniversary milestone that we proudly celebrated. Again I would like to extend our thanks and praise to the 125th Committee, headed by Councilwoman Regina Popichak, the various community organizations for their participation, our Department of Public Works, Carnegie Police Department, CVFD, our Borough Administration and the many others who made Carnegie's 125th, a year to remember.

This past Friday, we celebrated "Carols and Lights". It turned out to be another successful Carnegie event. We've received positive feedback from residents and the community and look forward to continuing this in the future. It was a team effort from, of course, the usual suspects: Carnegie Dept. of Public Works, Carnegie Police Department, Carnegie Volunteer Fire Dept. and Council. But there are two individuals who truly made it a phenomenal event, and that's Renea Holden and Deneen Underwood from Administration. These two women ignited their creativity and transformed the borough building into a scene out of a movie. Their hard work, dedication and teamwork was quite evident when you saw the looks on the faces of the children and residents that came out to enjoy the festivities. I don't have the words to express my sincere thanks and gratitude for all of their effort. I truly thank them from the bottom of my heart.

We look forward to that becoming another annual event in Carnegie.

We "Crawled" all year long in 2019 and had ribbon cutting ceremonies for Endure Barre and Scoops of Carnegie.

Our police department was able to raise money to offset the purchase of new guns for the department. We introduced surveys so that we can recognize the great work our department does in interacting with the people and we welcomed Officer David Butler. Chief Kennedy leads this department with professionalism, fairness and a constant drive to be proactive to ensure we keep Carnegie safe. We are always looking for areas of improvement and are committed to doing what is right. Thank you, Chief Kennedy.

I think what I heard most this year is how well all areas work together for the greater good of Carnegie. When we keep this as our main focus, great things happen. In my eyes, 2019 was an extraordinary year for Carnegie. We sadly have to say good-bye to two of our colleagues, Councilman Mike Sarsfield and Councilwoman Tess Canofari.

Mike – your experience and leadership will be greatly missed. You have served this community for many years. A true public servant. I truly thank you for your commitment to Carnegie and I wish you nothing but the best of luck in your future endeavors.
