ORDINANCE # 1052 (as amended)

- APPLICATION MUST BE ACCOMPANIED BY A CERTIFICATE OF INSURANCE NAMING THE BOROUGH OF CARNEGIE AS AN ADDITIONAL INSURED
- APPLICATION MUST BE ACCOMPANIED BY A SITE PLAN WITH DIMENSIONS, SHOWING CLEARLY AND COMPLETELY THE LOCATION OF THE PROPOSED SIDEWALK ACTIVITY
- PERMIT WILL NOT BE ISSUED FOR THE USE OF THE SIDEWALK WITHIN 20 FEET, IN EITHER DIRECTION, OF ANY FIRE HYDRANT
- GENERAL PUBLIC MUST HAVE A MINIMUM RIGHT-OF-WAY OF 5 FEET ON THE SIDEWALK
- PERMIT MUST BE OBTAINED ANNUALLY AND SHALL ONLY APPLY TO THE PERIOD FROM MAY 1 THROUGH OCTOBER 15
- ALCOHOLIC BEVERAGES PERMITTED BETWEEN THE HOURS OF 11 A.M. AND 11 P.M. WITH NO ALCOHOLIC BEVERAGES TO BE SERVED DURING THE CARNEGIE FESTIVAL SUBJECT TO AND ONLY WITH AN EXTENSION OF PREMISES LIQUOR LICENSE TO INCLUDE THE SIDEWALK AREA ISSUED BY THE PENNSYLVANIA LIQUOR CONTROL BOARD.
- APPLICATION MUST BE ACCOMPANIED WITH A \$25 NON-REFUNDABLE FILLING FEE

*APPLICATION IS HEREBY MADE FOR A SPECIAL PERMIT FOR AN OUTDOOR CAFE AT THE ABOVE ADDRESS. IT IS UNDERSTOOD BY THE APPLICANT THAT SAID PERMIT WILL AUTHORIZE ONLY THE APPLICANT STATED HEREIN AND THAT SUCH USE MAY NOT BE LEGALLY EXTENDED OR CHANGED WITHOUT AUTHORIZATION.
